Yabbaloumba Retreat ("us", "we", or "our") operates [www.yabbaloumbaretreat.com.au](http://www.yabbaloumbaretreat.com.au) (the "Site"). This page informs you of our policies regarding the collection, use and disclosure of Personal Information we receive from users of the Site.

We use your Personal Information only for providing and improving the Site. By using the Site, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, accessible at [www.yabbaloumbaretreat.com.au](http://www.yabbaloumbaretreat.com.au)

## Use of your Personal Information

We may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. Personally identifiable information may include, but is not limited to, your name, email address, postal address and phone number ("Personal Information").

Like many site operators, we collect information that your browser sends whenever you visit our Site ("Log Data"). This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Site that you visit, the time and date of your visit, the time spent on those pages and other statistics.

Yabbaloumba Retreat may collect and use the following kinds of personal information:

- Information about your use of this website
- Information that you provide using for the purpose of registering with the website (including online bookings)
- Information about transactions carried out over this website (including online bookings)
- Information that you provide for the purpose of subscribing to the website services (including newsletter subscription), and
- Any other information that you send to Yabbaloumba Retreat.

Yabbaloumba Retreat may use your personal information to:

- Supply to you services that you purchase
- Send to you invoices
- Collect payments from you, and
- Send you marketing communications.

## Sharing of your Personal Information

The privacy of our guests is of utmost importance and we do not disclose personal information to third parties for the purpose of allowing them to send marketing material to you.

However, unless we believe disclosure is appropriate to comply with a law, regulatory requirement, court order or a subpoena; to cooperate with law enforcement or other governmental investigations; to prevent or investigate a possible crime, such as fraud or identity theft; to protect legal rights, property or safety of you.



## Cross-border Disclosure

In some circumstances, Yabbaloumba Retreat may disclose personal information to third parties located outside Australia. This includes Beds24 for bookings made via our website. You agree and consent to the disclosure, transfer, storing or processing of your personal information outside of Australia. In providing this consent, you understand and acknowledge that countries outside Australia do not always have the same privacy protection obligations as Australia in relation to personal information. However, we will take steps to ensure that your information is used by third parties securely and in accordance with the terms of this Privacy Policy.
